Chairman's Report

It's wonderful to feel that, hopefully, we are now leaving the worst of the pandemic behind us, and to see our village community returning to normal life.Returning, just briefly, to the pandemic, January saw the official opening of the Tasburgh Rock Snake display board on the village green. Our thanks go to everyone whose imagination and efforts made this permanent addition to our village possible.

Another permanent addition to the village this year is the newly rebuilt village sign in Low Road. Thanks to Andrew Patrick for his hard work here, and also the Rev Austin, who, during the display board opening ceremony, also delivered a lovely blessing for both old and new village signs.

Climate change seems to be making itself evident in Tasburgh – we seem to have been much occupied this past year with problems of 'rot' everywhere. The wooden framework of the 'Spiders Web' and the basket swing in the playground have had to be completely replaced, and early problems have also been spotted with the boardwalk in Burrfeld Park, which is not a surprise as it sat under water for weeks last winter. We are currently looking at having the entire boardwalk washed and sprayed with preservative, which will hopefully ensure its survival for a few more years to come.

The other constant problem facing us is that of traffic and speeding around the village. The Parish Council have received funding under the Norfolk Public Partnership scheme to buy a second SAM2 machine. This new machine will concentrate on various speeding blackspots on the Low Road, leaving the other machine to be based in Church Road and Grove Lane. With the provision of two SAM2 we can start to build up evidence about the very noticeable problems in the village and hopefully come up with future solutions. A Traffic Advisory Group has also been set up specifically to try and address some of these problems.

Your Council Tax 2021/22

The Parish Council is pleased to report that the precept (the parish council's share of the council tax) saw no increase for the financial year 2021/22. Budgeted general expenditure has remained broadly the same as the previous year. The Parish Council had ear-marked funds for potential identified projects and grant funding which could be applied for by local community groups. Any remaining funds at year end continue to be transferred into the contingency funds for Burrfeld Park and the Playarea. The Parish Council remains in a good financial position, maintaining good value for money on all purchases and projects.

Neighbourhood Plan

The Plan continues to be community led and evidence based. In 2021/22 the Neighbourhood Plan Advisory Group held two well attended public consultation events in the Village Hall which formed the Vision for the Plan and a set of Objectives, both of which have been accepted by the Parish Council. Thank you everyone who came along and willingly gave their views and comments on a range of subjects.

The Advisory Group is now in a position to apply for funding from the national organisation (Locality) which supports community led planning. This will enable the Parish Council to employ specialist planning consultants to deal with specific areas of the plan prior to submission. The group is currently in the process of conducting a Village Character Assessment.

The Assessment will include details of the building styles, materials and ages and their relationship with the surrounding landscape. This will be a useful tool in identifying the special qualities that give Tasburgh a sense of place and in informing design guidance in any future development in the Village.

Burrfeld Park

Despite COVID restrictions a couple of work days were held with some dozen people working, observing social distancing. Others were doing the routine maintenance, which keeps the Park open and useable to all residents. Once again our thanks to all volunteers for their hard work in these curious times. The floods and heavy rain last year resulted in marked growth throughout the Park, however there was a good crop of Norfolk Heritage apples and we were pleased that residents helped themselves.

Tasburgh Rock Snake

January saw the long awaited grand unveiling of the Tasburgh Rock Snake display board on the village green. The rock snake which formed such a lovely display along Grove Lane at the height of the lockdown in 2020, began from a conversation between Laura Boon, Emma Townsend and Amy Prendergast. They placed a notice on the fence of the field next to the village hall, inviting people to place painted stones along the footpath. This grew until there were 278 stones. Not wanting to lose this, the Parish Council agreed to fund a more permanent feature to commemorate this time.

Our thanks to everyone whose efforts have enabled this and we hope that it will be something to be enjoyed for many years. We would also like to extend our thanks to Mrs Philippa Taylor, the Deputy Lieutenant for Norfolk, who unveiled the board and presented the village with a Covid memorial token, and to Rev

Austin Uzoigwe, who delivered a beautiful blessing for both of our village signs.
